Government Code, Chapter 551, that the Board of Supervisors of Fort Bend County Fresh Water Supply District No. 1 will meet in **regular** session, open to the public, at **6:00 o'clock p.m.**, on **THURSDAY, February 16, 2017**, at the Mustang Community Center, **4521 F.M. 521 North, Fresno, Fort Bend County, Texas, 77545**, a designated meeting place inside the boundaries of the District, at which meeting the following items will be considered:

**1. Review Bookkeeper's Report and consider taking action thereon, including:**

- A. Approval of bills submitted to the District for payment.
- B. Review Investment Report and authorize necessary action in connection therewith.
- C. Review Collateral Pledge Report and Investment Policy and authorize necessary action in connection therewith including any amendments or changes thereto.
- D. Approve amended budget for fiscal year ending December 31, 2017.

- F. Approve Application to Texas water Development Board for Project and Issuance of Bonds, Series 2017.
- G. Approve Resolution Concerning Tax Exemptions for 2017.

- I. Approve Resolution Authorizing 20% Penalty on Delinquent Taxes.
- J. Adopt Order Calling Bond Election.

- C. Approval of water termination list.


**5. Review Engineer's Report and consider taking action thereon, including:**

- A. Report on status of projects including: (i) water service to Teleview Terrace, Marble Estates and Ridgewood Estates, North and South Teague Road, and take action related thereto, including authorize advertisement of bids, award of contracts, approval of pay estimates and change orders.
- B. Authorize Engineer to prepare plans and specification for water and wastewater systems projects as necessary.
- C. Authorize solicitation/advertisement of bids for construction of water system and wastewater system projects necessary.
- D. Report on status of project funding, including extension of federal grant, and take necessary action related thereto.
- E. Consider and take action on requests for water and sanitary sewer service.
