Government Code, Chapter 551, that the Board of Supervisors of Fort Bend County Fresh Water Supply District No. 1 will meet in **special** session, open to the public, at **4:30 o'clock p.m.**, on **THURSDAY, APRIL 21, 2016**, at the Mustang Community Center, **4521 F.M. 521 North, Fresno, Fort Bend County, Texas, 77545**, a designated meeting place inside the boundaries of the District, at which meeting the following items will be considered:

**1. Discuss and take action on private water well policy.**

**7. Review Engineer's Report and consider taking action thereon, including:**


- A. Report on status of projects including, (i) Teleview Terrace Lift Station and Force main, (ii) water service to Teleview Terrace, Marble Estates and Ridgewood Estates, North and South Teague Road, and take action related thereto, including authorize advertisement of bids, award of contracts, approval of pay estimates and change orders.
- B. Authorize Engineer to prepare plans and specification for water system and wastewater systems projects as necessary.
- C. Authorize solicitation/advertisement of bids for construction of water system and wastewater system projects necessary.
- D. Report on status of project funding, including extension of federal grant, and take necessary action related thereto.
- E. Consider and take action on requests for water and sanitary sewer service.
