

NOTICE OF SUPERVISORS ELECTION

TO THE QUALIFIED ELECTORS OF FORT BEND COUNTY FRESH WATER SUPPLY DISTRICT NO. 1,
AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given that an election will be held within Fort Bend County on the 5th day of May, 2018, between the hours of 7:00 a.m. and 7:00 p.m., for the purpose of electing two (2) members of the Board of Supervisors.

The District has entered into a Joint Election Agreement and Contract for Election Services (the "Contract") with Fort Bend County (the "County") which provides that the County will conduct the election on behalf of the District.

A copy of the Order and Contract are available in the office of the District at 1980 Post Oak Boulevard, Suite 1380, Houston, Texas 77056.

Subject to the provisions of Chapter 31, Subchapter D of the Election Code, the District agrees to allow the County to administer an election to be held for the District on May 5, 2018, between the hours of 7:00 a.m. and 7:00 p.m., at a place to be determined by the County. Pursuant to the Contract, the District has directed that the place for the election be a suitable public building and a proper place for conducting said election.

Voting in said election shall be by the use of an electronic voting system prepared by the County pursuant to the Contract and Texas Election Code, Chapter 123. Ballots shall be printed in both English and Spanish as required by federal voting rights law.

Oral assistance in Spanish shall be made available to all persons requiring such assistance. Any person requiring oral assistance in Spanish should contact the presiding judge or absentee voting clerk.

The boundaries of the District are hereby designated as and shall constitute one election precinct for the election. The Elections Administrator of Fort Bend County (the "Administrator") shall appoint the presiding judges and clerks for the election pursuant to the Contract. The Administrator may appoint, as he or she deems necessary, clerks to assist in the conduct of the election.

The early voting ballot board shall be appointed by the Administrator in accordance with the Contract.

Early voting in the election by personal appearance shall occur as provided by the County pursuant to the Contract. The clerk for early voting shall be the Administrator, and the place at which such early voting shall be conducted is to be determined by the County pursuant to the Contract. The places and times at which early voting by personal appearance shall be conducted and voting on election day are set forth in Exhibit "A" hereto. The early voting clerk's mailing address to which ballot applications and ballots to be voted by mail may be sent is Mr. John Oldham, Elections Administrator of Fort Bend County, 301 Jackson Street, Suite 100, Richmond, Texas 77469-3108. The email address at which the clerk for early voting may receive applications for a ballot to be voted by mail is vote@fortbendcountytexas.gov.

The Administrator is hereby appointed as the agent for the Secretary of the Board of the District for the purpose of being custodian of the election records. The agent shall maintain election records in accordance with the Texas Election Code.

All qualified resident electors of the District shall be entitled to vote in the election.

Se notifica por el presente que se celebrará una elección en el Condado de Fort Bend el 5 de mayo de 2018 en el horario de 7:00 a.m. a 7:00 p.m., con el propósito de elegir dos (2) miembros para la Junta de Supervisores del Distrito:

El Distrito acordó un Convenio de Elecciones Conjuntas y Contrato de Servicios Electorales (el "Contrato") con el Condado de Fort Bend, el cual dispone que el Condado estará a cargo de la conducción de la elección en nombre del Distrito.

Una copia de la Orden y el Contrato se encuentran disponibles en la oficina del Distrito en 1980 Post Oak Boulevard, Suite 1380, Houston, Texas 77056.

Sujeto a las disposiciones del Subcapítulo D del Capítulo 31 del Código Electoral, el Distrito acuerda permitir al Condado administrar una elección a celebrarse para el Distrito el 5 de mayo de 2018 de 7:00 a.m. a 7:00 p.m. en un lugar que será determinado por el Condado. En conformidad con el Contrato, el Distrito ha instruido, que el lugar de la elección sea un edificio público adecuado y un lugar adecuado para la celebración de dicha elección.

La votación en dicha elección será mediante el uso de un sistema votación electrónica preparado por el Condado en conformidad con el Contrato y con la Sección 123 del Código Electoral de Texas. Las boletas de votación estarán impresas en inglés y español, según lo exige la ley federal de derechos de votación.

Habrà disponible asistencia verbal en español para todas las personas que la requieran. Cualquier persona que necesite asistencia verbal en español se deberá comunicar con el juez presidente o con el oficial de votación en ausencia.

Por medio de la presente los límites del Distrito son designados como un y constituirán un precinto electoral para las elecciones. El Administrador de Elecciones del Condado de Fort Bend (el "Administrador") deberá designar al juez presidente y funcionarios para la elección en conformidad con el Contrato. El Administrador puede designar, según lo considere necesario, funcionarios para asistir en la celebración de la elección.

El consejo de boletas de votación anticipada será asignado por el Administrador en conformidad con el Contrato.

La votación anticipada en persona de la elección se llevará a cabo según lo disponga el Condado en conformidad con el Contrato. El oficial de votación anticipada será Administrador, y el lugar donde se llevará a cabo la votación anticipada será determinado por el Condado en conformidad con el Contrato. Los lugares y fechas en los que se llevará a cabo la votación anticipada en persona y votar el día de las elecciones son indicados en el Anexo "A" del presente. 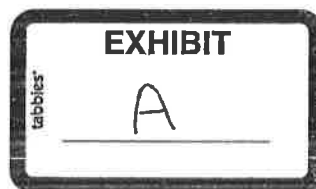
